Profile

I study how political elites and citizens form preferences about controversial issues in different political environments, and how elites shape political views and the behavior of citizens through mobilization, persuasion, and information provision. My research investigates contemporary episodes of political competition, such as the conflict over European integration, and historical cases, such as the formation of class politics. I approach these and other instances of political conflict from a comparative perspective, and I treat them as milestones of a long-term process of political development. To understand this process and its manifestations as distinctly political phenomena, I combine the comparative macro-analysis of institutions and political competition with a micro-level psychological perspective that pays attention to both cognitive and motivational factors. My research engages the fields of comparative politics, EU studies, political development, and public opinion. The geographical focus of my research is on Europe and the United States. Combining quantitative and qualitative approaches, the methods I use include experiments, comparative case studies, surveys, elite interviews, and text analysis.
